

Lawn Service Fall Clean-up

The lawn service will make the <u>last yard-waste pick up for the season on Friday</u>, <u>November 28th (weather permitting)</u>, so have your yard waste bags ready!! The lawn service contract has a <u>November 28th end of service date</u>. The hard-working staff at Clean Cut Lawn Service will <u>begin fall clean-up of leaves approximately mid-to late October</u>, or when the trees begin to drop the leaves. This gives the lawn crew time to go one-time through the entire Association property. Once that has been completed, if there is still time before the contract end date, they will go back and knock out some of the heavier areas that had dropped leaves after they had gone through initially. With the Association being located on the edge of the National Forest, the strength and direction of the autumn winds is an ever-present factor in where all those loose leaves from the forest will end up.

Clean Cut must also rely on "Mother Nature" to keep to her time clock and work through the leaf color-change and fall-off cycle so the team can clean up the fallen leaves. However, as we have experienced in past years, some of the trees do not cooperate and don't shed their leaves until after our contract expires; or worse yet, we get an early freeze and snow, thus preventing the final clean up tasks from getting completed. This may result in some of the leaves not being collected until spring snow melt. Stress not.....lawn care service will begin in early spring to collect any late fallen leaves as well as tree limbs and branches that were knocked down by strong winds over the winter months.

Homeowners should have outside porch lights on where trick-or-treaters are welcome.


 Drivers should be especially aware and observant when driving through residential neighborhoods.

Drivers don't text & drive. Be alert!

Restrain pets so they do not inadvertently jump on or bite a trick-or-treater.











A local contractor recently reported replacing **about 50 cracked heat exchangers** in the older tan furnaces commonly found in homes here. And that's just one contractor—we suspect many more have been replaced by others.

Furnaces that are 15 years or older are most at risk, and once a crack forms, dangerous gases like **carbon monoxide**, **sulfur dioxide**, **and nitrous oxide** can leak into your home. Carbon monoxide is especially dangerous—it's odorless, colorless, and one of the leading causes of poisoning in homes.

The tricky part is, you may never know there's a crack until your **carbon monoxide detector goes off**. That's why it's important to have your furnace inspected by a licensed HVAC technician, especially if it's more than 15 years old.

Protect your family's safety:

- Schedule a professional furnace inspection.
- Install a carbon monoxide detector on every floor of your home.

Don't wait for the beep—take action before danger strikes.

Winterizing the Garden

As we all prepare our gardens for the upcoming winter season, please keep the following guidelines in mind:



- You must have your yard waste in brown paper bags with your address number listed on the bag(s). **Yard waste placed in plastic bags will not be picked up**.
- » Bags must be limited to 30 lbs. each and no more than 6 bags and/or bundles.
- » No dirt, pet waste, or garbage should be in the bags or they will not be picked up.
- » Bags must be out to the curb before 8 a.m. on Friday or they will not be picked up.
- » Branch piles (shrubs, small tree limbs or branches) must be limited in size to a maximum of four (4) feet in length and two (2) feet in circumference and *must be "bundled" or*

tied together to prevent them from falling out of the trailer during transport.


» Your yard waste will not be picked up if these guidelines are not followed. No yard waste bags should be left in view all week long. We ask that you please store them out of sight until they are placed by the road for Friday pickup. Thank you!

Fall Home Maintenance



With autumn sneaking in, it's a great time of year to take care of a little home maintenance. This will help prevent costly repairs and safety issues down the line.

<u>Smoke/Carbon Monoxide Detectors</u> Replace the batteries. With colder nights just around the corner, your furnace will run more often, and a carbon monoxide detector will detect if the colorless, odorless gas is leaking into your home.

<u>Fire Extinguisher</u> Check that the gauge needle is in the green, the safety pin is in place, and there is no visible damage to the hose and handle. Replace if any of these don't pass inspection.

Furnace Turn on the furnace and run it for 5 or 10 minutes to make sure if it's functioning properly. Also, many heating and cooling companies provide cleaning and tune up services at special rates.

<u>Thermostat</u> Replace batteries in the thermostat control (they have batteries too).

<u>Washer/Dryer</u> Check that there aren't any leaks around the waterlines and they are free of cracks. If your drain line empties into a utility tub, add a lint trap sleeve. It will prevent lint from clogging the drain, and just replace it as needed. It is recommended to clean out the dryer lint trap after every load.

⇒ Holiday decorations must be removed within 10 days after the holiday. This includes Halloween decorations, pumpkins, hay bails and Jack-o-lanterns.



- ⇒ Beginning in October and running through April, the ACC will only meet once per month, on the 2nd Thursday of the month.
- ⇒ Parking on all streets is strictly prohibited between November 1st and April 1st from 8am to 5pm in order to facilitate County snow removal. This will also help prevent the ice and snow build up from becoming a hazard to other drivers and pedestrians. (See Bylaws Article VII, Section 2(a)).
- \Rightarrow **4-Plex Owners**: Remember to trim the bushes by the trash shed so that the snow removal crew is able to access the area to clear a path to... and in front of the shed door.
